2. All competitors must be registered with the ASA or their own national association as appropriate
3. Closing Date: Friday 1st October 2023
4. Age on day gala
5. Pool length is 25 meters it has 6 lanes fitted with anti- wave lane ropes
6. Electronic timing system will be in operation
7. Age groups are 9, 10, 11, 12, 13, 14, 15 plus
8. Swimmers must not be faster than the time limits quoted on the table attached. Any swimmers entered on faster times than that for their age and event will be excluded. All entry times must be converted to 25m pool times by use of the ASA Conversion tables. Training times will be considered.
9. Fees & Charges

 - Coach passes - £25.00 to include lunch and set of electronic results

14. Medals will be awarded for 1st 2nd and 3rd in age group events. Age groups, 9, 10, 11, 12, 13, 14, 15 plus
15. All competitors must go through marshalling for both heats and finals. If a competitor does not report to marshalling in time the event will proceed without the competitor.
All events will be Heat Declared Winners.
16. Coaches/Team Managers must notify the recorders 40 minutes before the start of the session if any of their swimmers have withdrawn.
